

AUDI DRIVING EXPERIENCE LUCKY DRAW ("LUCKY DRAW")
(as of 30 April 2026)

Terms And Conditions

This Lucky Draw is carried out by Audi Singapore Pte Ltd ("**Audi**") and is subject to these terms and conditions ("**Terms**").

The images used in publicity for the Lucky Draw are for illustrative purposes only. The destination for the Audi Driving Experience has not been determined and may not be the same as the destination used in the images.

1. Eligibility

- 1.1. To participate in the Lucky Draw, an eligible person must make a Valid Purchase.
- 1.2. To make a Valid Purchase, the eligible person must:
 - (a) Purchase existing stock of an Audi vehicle from 7 May 2026 until 3 June 2026 ("**Promotion Period**");
 - (b) Submit the Vehicle Sales Agreement during the Promotion Period; and
 - (c) Register and fully pay for the vehicle by 31 August 2026.

Note: Order of any vehicles which are not immediately available is not counted as a Valid Purchase

- 1.3. In these Terms, an "**Eligible Participant**" is an eligible person who has made a Valid Purchase.
- 1.4. Upon making each Valid Purchase during the Promotion Period, an Eligible Participant is entitled to:
 - (a) One entry into the Lucky Draw
 - (b) For the first eighty (80) Eligible Participants only, one chance at the Audi blind box vending machine for gifts as determined by Audi
- 1.5. Only natural persons are eligible to participate in the Lucky Draw. Corporate or other entities are not eligible to participate in the Lucky Draw.
- 1.6. Notwithstanding Clause 1.3 above, employees and members of management of the following entities and/or the following persons shall not qualify as Eligible Participants:
 - (a) Audi; or
 - (b) Any person involved in organizing, promoting and/or conducting the Lucky Draw.
- 1.7. Notwithstanding Clause 1.3 above, immediate family members (i.e. grandfather, grandmother, father, mother, brother, sister, son and/or daughter) of any person referred to in Clause 1.6 above shall not qualify as Eligible Participants.

- 1.8. Notwithstanding the aforesaid, Audi reserves the sole and absolute discretion to determine the eligibility of any person in relation to the Lucky Draw at any time.

2. Participation in the Lucky Draw

- 2.1. By participating in the Lucky Draw, each Eligible Participant:
 - (a) agrees to be bound by these Terms and any amendments thereof, including all Terms relating to the obligations of the Winner (as defined at Clause 3.2 below); and
 - (b) agrees to be bound by the decisions of Audi, which are final and binding in all matters relating to the Lucky Draw.
- 2.2. Failure to comply with these Terms shall result in an automatic disqualification from the Lucky Draw and/or where applicable, the immediate forfeiture of the Prize.

3. Conduct of the Lucky Draw

- 3.1. Audi will conduct a digital draw of the Lucky Draw on **9 September 2026 at 3pm**, or at any other date determined by Audi ("**Draw Date**").

Notification of Winner

- 3.2. On the Draw Date, one (1) winner ("**Winner**") will be selected at random by Audi personnel and/or representatives by conducting a digital draw in the presence of a scrutineer which will be appointed by Audi solely for the purposes of the Lucky Draw and who has no association with Audi (the "**Independent Scrutineer**"). On the Draw Date, four reserve winners (each a "**Reserve Winner**") will also be selected at random by Audi personnel and/or representatives by conducting a digital draw in the presence of the Independent Scrutineer.
- 3.3. The Winner will be notified via a phone call from Audi by 15 September 2026 (i.e. within a week from the Draw Date) to claim the Prize (as defined at Clause 4.1 below) ("**Notification Date**"). The Winner shall thereafter confirm his/her acceptance of the Prize to Audi within fourteen (14) calendar days from the Notification Date, providing such information and documents as Audi may require.
- 3.4. The name of the Winner will also be published on Audi's website promptly upon the Winner being selected, subject to Clause 3.5 – 3.7.

Disqualification of Winner or Rejection of Prize

- 3.5. Audi reserves the right and sole and absolute discretion to disqualify (a) the Winner; or (b) any participant from the Lucky Draw if Audi (in its sole and absolute discretion) believes that the Winner or participant is not eligible to participate in the Lucky Draw, may have contravened, will contravene or has contravened any

of these Terms and/or may bring Audi into disrepute. If a Winner is disqualified, the Winner's right to the Prize will be forfeited without any compensation.

- 3.6. If the Winner is disqualified for any reason or rejects the Prize, Audi may replace the Winner with the Reserve Winner according to the sequence in which the Reserve Winner is drawn (i.e. the Winner will be replaced with the first drawn Reserve Winner; the first drawn Reserve Winner will be replaced with the second drawn Reserve Winner, etc). In such a case, Clauses 3.2 to 3.4 above shall apply, save that the Draw Date will be replaced with the date the Winner (or the Reserve Winner, as the case may be) is disqualified.
- 3.7. If all Reserve Winners are disqualified or do not wish to accept the Prize, Audi reserves the right to forfeit the Prize.
- 3.8. Audi's decisions shall be final and conclusive, including any decision as to the disqualification of the Winner, selection of the Reserve Winners or forfeiting the Prize.

4. Prize and Booking of Prize

- 4.1. Subject to Clause 4.2 below, the Winner will win a 3 Days 2 Nights Audi Driving Experience in a destination of Audi's sole and absolute discretion valued at approximately S\$10,000. The Audi Driving Experience shall include:
 - (a) 2 sets of return air tickets (economy class) to a destination within Europe (as chosen by Audi at its sole and absolute discretion);
 - (b) 2-night's hotel accommodation (at a hotel as chosen by Audi at its sole and absolute discretion);
 - (c) A meal package (including breakfast, lunch and dinner but excluding beverages) for 2 persons for the duration of the Audi Driving Experience of 3 days; and
 - (d) Rental of an Audi vehicle (as chosen by Audi at its sole and absolute discretion) for 3 days, subject to standard rental terms used in respect of such vehicle.
- 4.2. The Prize is subject to the following terms and conditions:
 - (a) The Prize must be redeemed by 31 December 2027. In the event of failure to redeem the Prize for any reason whatsoever within the stipulated time period, the Prize will be forfeited without any compensation.
 - (b) The Prize is non-transferable, non-refundable and cannot be exchanged for cash, credit, goods or benefits in kind, or combined with other promotions or discounts.
- 4.3. The Winner shall be required to produce (i) his/her identity card, (ii) his/her driving license, and (iii) any other documents as may be requested by Audi in order to claim the Prize.
- 4.4. If the Winner fails to provide any of the required documents and details, Audi shall have no further obligation nor be obliged to deliver the Prize. Audi shall

thereafter not be responsible or liable to the Winner or any other person for any damages, losses, costs or expenses whatsoever in the event that Audi does not deliver the Prize to the Winner on the ground that the Winner failed to provide Audi with / Audi did not receive from the Winner all the necessary documents and details.

5. Others

- 5.1. In the event that the consumption of the Prize incurs any additional costs or tax liability, such additional costs or tax, including but not limited to visa costs, travel insurance, airport taxes, baggage fees, incidentals, gratuities, and any income or withholding tax, is the sole responsibility of the Winner.
- 5.2. The consumption of the Prize shall be subject to the Terms herein and all such further terms and conditions which Audi and/or its Affiliates (as defined at Clause 5.17 below) may notify the Winner before the consumption of the Prize.
- 5.3. Audi shall retain sole and absolute discretion in deciding on all matters relating to the Lucky Draw and all of Audi's decisions shall be final and binding on all Eligible Participants. Audi shall not be obliged to enter into any correspondence/discussion with any Eligible Participant with regard to Audi's decisions.
- 5.4. Each Eligible Participant hereby expressly consents to, and grants to Audi and its Affiliates the right to use the information submitted by the Eligible Participant (pursuant to any survey or poll conducted by Audi) in any manner as Audi shall see fit.
- 5.5. By participating in the Lucky Draw, each Eligible Participant acknowledges that Audi and its Affiliates shall, in accordance with applicable data protection laws and Audi's privacy policy (which may be found at <https://www.audi.com.sg/en/tools/privacy/>), have the right to, and the Eligible Participant gives his/her consent to Audi and its Affiliates to collect and store the personal data/information submitted by each Eligible Participant for the following purposes:
 - (a) entry into the Lucky Draw;
 - (b) to publish his/her name on Audi's website if the Eligible Participant is the Winner;
 - (c) to contact and/or mail the Eligible Participant (whether electronically or otherwise) at any time with information and/or mailers containing customer service, business, marketing, advertising and/or promotional information of any kind, whether or not related to Audi's programmes, contests, promotions and/or activities, and Audi shall additionally have the right to provide goods and/or services whether by Audi directly or by Audi's Affiliates, designated representatives and/or business partners to the Eligible Participant,
 - (d) to conduct market research and analysis, including surveys and polls, and

- (e) to send the Eligible Participant information, promotions and updates including marketing and advertising materials in relation to Audi and its Affiliates' goods and services and those of third party organizations selected by Audi.
- 5.6. By participating in the Lucky Draw, each Eligible Participant agrees to take part in any and all marketing, promotional, publicity exercise as may be conducted by Audi and/or its Affiliates arising or with respect to the Lucky Draw and the Eligible Participant irrevocably and unconditionally grants to Audi and its Affiliates all consents and waivers necessary for Audi and its Affiliates to record and use the Eligible Participant(s)' performance, appearance, likeness and/or particulars as the case may be, in any manner whatsoever and in any part of the world as Audi and its Affiliates shall in their sole and absolute discretion deem fit. The Eligible Participant acknowledges that Audi and its Affiliates shall be at liberty to publish and otherwise use any recordings made by Audi and/or its Affiliates, including without limitation the information on the Lucky Draw, telephone call, telephone recordings, audio recordings, visual recordings and photographs, for the promotion and publicity of the Lucky Draw. The Eligible Participant hereby expressly waives any and all rights which the Eligible Participant may acquire or have under the provisions of the Copyright Act 2021 of the Republic of Singapore including any subsidiary legislation (and any subsequent enactment or amendments thereto) and any other moral rights which the Eligible Participant(s) may have or be entitled under any such legislation now existing or in the future enacted in any part of the world.
- 5.7. Each Eligible Participant irrevocably releases Audi and its Affiliates from and against any and all claims, suits, liabilities, or damages which such person may have in connection with his or her particulars or personal data/information which he/she has provided to Audi and/or Audi's Affiliates, which particulars or personal information has been and/or is being (i) used by Audi and/or its Affiliates (or any third party which Audi has released the particulars/information to) in any manner or format; and/or (ii) disclosed or otherwise provided by Audi and/or its Affiliates to any third party, for the purposes provided herein (including that as set out in Clause 5.6 above).
- 5.8. Notwithstanding anything contained herein, Audi reserves the right at any time, in its sole and absolute discretion to partially or completely postpone or cancel the Lucky Draw, to substitute the Prize with any other item of a similar value or to amend, and/or add and/or delete any of these terms and conditions without prior notification to Eligible Participants and without assigning any reason, and all Eligible Participants shall be bound to such amendments, additions or deletions when effected.
- 5.9. By accepting the Prize and participating in the Audi Driving Experience (including any driving activities, air travel, and any related activities overseas), the Winner (and, where applicable, the Winner's companion(s)) expressly acknowledges and accepts that the Audi Driving Experience involves inherent risks, including but not limited to risks associated with driving a motor vehicle in an unfamiliar

overseas environment, road and weather conditions, air travel, physical exertion, and unforeseen events. The Winner (and, where applicable, the Winner's companion(s)) confirms that they have voluntarily chosen to participate in the Audi Driving Experience with full knowledge, understanding, and appreciation of such risks, and assumes all such risks to the fullest extent permitted by applicable law.

- 5.10. To the fullest extent permitted by applicable law, the Winner (and, where applicable, the Winner's companion(s)) irrevocably and unconditionally waives any and all claims, actions, proceedings, demands, rights, and causes of action of whatever nature which any of them may have or may hereafter have against Audi and its Affiliates and their respective officers, directors, agents, and employees (collectively, the "**Released Parties**") arising out of, in connection with, or relating to their participation in the Audi Driving Experience, including but not limited to any loss, damage, injury (including personal injury), illness, death, or expense of any nature whatsoever.
- 5.11. To the fullest extent permitted by applicable law, Audi and its Affiliates shall not be liable in any way to any Eligible Participant, the Winner, the Winner's companion(s) or any other person for:
- (a) any loss, damage, injury (including personal injury), illness, death, cost, or expense of any nature suffered incurred by any of them which arises out of, in connection with, or relating to the Lucky Draw, the Prize or the Audi Driving Experience (including any driving activities, air travel, accommodation, meals, or any other activities undertaken during or in connection with the Audi Driving Experience);
 - (b) any act or omission relating to any person's participation in the Lucky Draw or the Audi Driving Experience however caused;
 - (c) late or non-notification of any information in relation to the Lucky Draw or Prize;
 - (d) incomplete, lost, late, damaged, illegible or misdirected notices;
 - (e) mail, e-mail, technical, hardware or software breakdown of any kind;
 - (f) lost or unavailable network connections or failed, incomplete garbled or delayed electronic transmission or transactions, which may limit an Eligible Participant's ability to participate in the Lucky Draw or claim the Prize;
 - (g) the occurrence of any Force Majeure Event, where a "Force Majeure Event" means any event or circumstance beyond the reasonable control of Audi which prevents or materially delays the performance of any of its obligations in relation to the Lucky Draw or the Audi Driving Experience, including without limitation acts of God, natural disasters, epidemics or pandemics, war, terrorism, civil unrest, labour disputes not involving Audi's workforce, governmental actions or restrictions or sanctions, shortages or unavailability of transportation, travel advisories or restrictions, or the failure of suppliers or subcontractors not caused by Audi; or
 - (h) any act, omission, default, or negligence on the part of any third-party service provider, airline, hotel, vehicle rental company, tour operator, or other person involved in the provision of any component of the Audi Driving Experience.

- 5.12. The Eligible Participant shall indemnify and keep Audi and its Affiliates and their respective directors, officers, agents and employees ("**Indemnified Parties**") fully indemnified against any and all losses, damages, liabilities, claims, actions, proceedings, costs, and expenses (including legal costs on a full indemnity basis) suffered and/or incurred by any of the Indemnified Parties which arises out of, in connection with, or relating to: (a) the Eligible Participant's breach of any of these Terms.
- 5.13. The Winner shall indemnify and keep the Indemnified Parties fully indemnified against any and all losses, damages, liabilities, claims, actions, proceedings, costs, and expenses (including legal costs on a full indemnity basis) suffered and/or incurred by any of the Indemnified Parties which arises out of, in connection with, or relating to: (a) the Winner's or the Winner's companion(s)' participation in the Audi Driving Experience, including any claims brought by the Winner's companion(s) or any third party in connection with the Audi Driving Experience; or (b) any act, omission, default, or negligence of the Winner or the Winner's companion(s) during or in connection with the Audi Driving Experience, in each case to the fullest extent permitted by applicable law.
- 5.14. To the extent that any provision of these Terms is found to be unenforceable or void under any applicable law, such provision shall be deemed to be modified to the minimum extent necessary to make it valid and enforceable, and the remaining provisions of these Terms shall continue in full force and effect.
- 5.15. In the event of any inconsistency between these Terms and any brochure, marketing or promotional material relating to the Lucky Draw, the Terms contained herein shall prevail.
- 5.16. Any person who is not an Eligible Participant may not enforce any of these Terms under the Contracts (Right of Third Parties) Act 2001. For the avoidance of doubt, Audi and its Affiliates shall have the right to enforce any of these Terms.
- 5.17. For the purposes of these Terms, "**Affiliate**" of Audi shall mean any corporation, company, partnership or other entity (whether in Singapore or elsewhere) which is controlled by Audi; controls Audi; or is under common control with Audi. For this purpose, "**control**" means the authority or ability, whether exercised or not, to control an entity's business and affairs, which authority shall conclusively be presumed to exist when more than fifty per cent (50%) of the controlled entity's outstanding shares or ownership interest representing the right to make decisions for such entity are owned or controlled, directly or indirectly, by the controlling entity, and/or the controlling entity possesses, directly or indirectly, the power to influence the decision-making process, the direction of management, and the policies of the controlled entity.
- 5.18. The aggregate liability of Audi and its Affiliates in relation to the Lucky Draw and Prize shall not exceed S\$10,000 unless otherwise specified by law.

5.19. The Terms shall be governed by and construed in accordance with the laws of the Republic of Singapore and each of Audi and the Eligible Participants shall submit to the non-exclusive jurisdiction of the Courts of the Republic of Singapore.
