Life cycle assessment

Audi A6 Avant TDI quattro 220kW S tronic*

AUDI AG prepares a detailed life cycle assessment for new vehicle models at the start of production.

In the following, the Audi A6 Avant TDI quattro 220kW S tronic* with the German standard equipment without additional optional equipment is considered.

The methodology

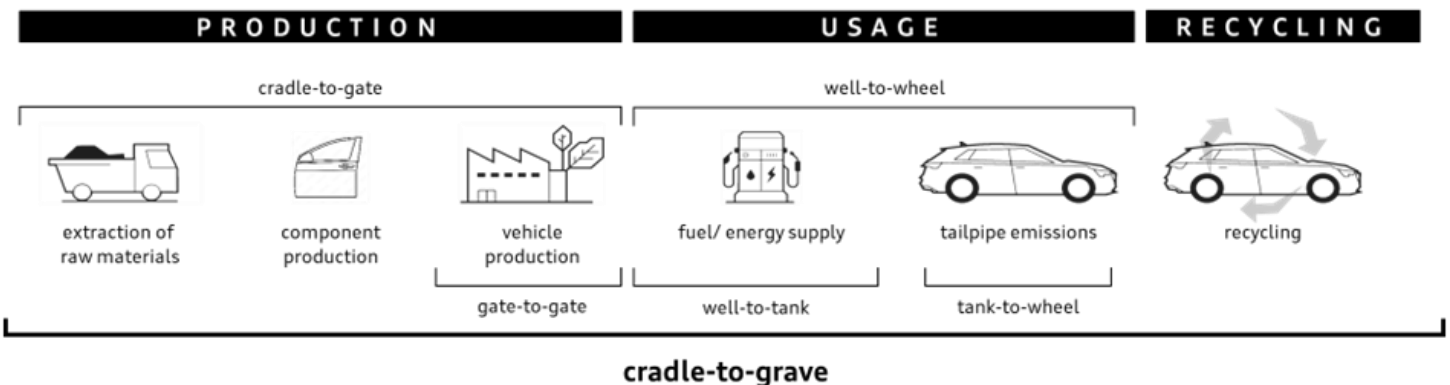


Figure 1: Scope of investigation of a life cycle assessment

The life cycle assessment (LCA) analyzes the environmental impact of a product throughout its life cycle (cradle-to-grave, see Figure 1). In a life cycle assessment for an AUDI AG vehicle, this is broken down into the following phases:

- **Production:**

Manufacture of the components (from the raw material to the finished component) and production of the vehicle model.

- **Usage:**

Use of a vehicle model based on a predefined driving profile (WLTP) with a mileage of 200,000 km including upstream processes from the fuel or energy supply.

- **Recycling** at the end of the product life.

In this life cycle assessment, the ecological impact categories of greenhouse potential, ozone formation potential, acidification potential, and eutrophication potential are quantitatively assessed. Further explanations can be found below.

When preparing the life cycle assessment, AUDI AG follows the procedure standardized in the international series of standards ISO 14040 ff.

The following premises were used as a basis for preparing the life cycle assessment:

- Production year 2026, model year 2026
- Material data and component parts list of the examined vehicle model
- Combined fuel consumption according to WLTP in 2026
- 200,000 km mileage in the use phase
- Testing and validation by independent experts (TÜV NORD CERT GmbH)

The life cycle assessment software “LCA for Experts” version 10.9.4.13 was used.

The results - global warming potential over the entire life cycle

The global warming potential (GWP) describes the emissions of greenhouse gases that lead to an increase in the heat absorption of solar radiation in the atmosphere and thus can contribute to an increase in the global average temperature. The reference substance for the global warming potential is carbon dioxide (CO₂), to which all other active substances (e.g. methane (CH₄), nitrous oxide (N₂O), sulfur hexafluoride (SF₆), volatile organic compounds (VOC)) are related (CO₂ equivalents - CO₂-eq.).

The Audi A6 Avant TDI quattro 220kW S tronic* generates approximately 48.4 tons of CO₂-equivalent greenhouse gas emissions over its entire lifecycle. During the manufacturing and logistics phase, the greenhouse gas emissions of the Audi A6 Avant TDI quattro 220kW S tronic* are approximately 12.7 tons of CO₂-equivalent of which logistics account for approximately 0.4 tons of CO₂-equivalent. The usage phase of the Audi A6 Avant TDI quattro 220kW S tronic* accounts for approximately 7.2 tons of CO₂-equivalent in fuel provision, as well as 27.1 tons of CO₂-equivalent for driving emissions, which in total corresponds to almost 70 % of the total greenhouse gas emissions over the life cycle. Maintenance generates 1.4 tons of CO₂-equivalent. Disposal generates 0.03 tons of CO₂-equivalent.

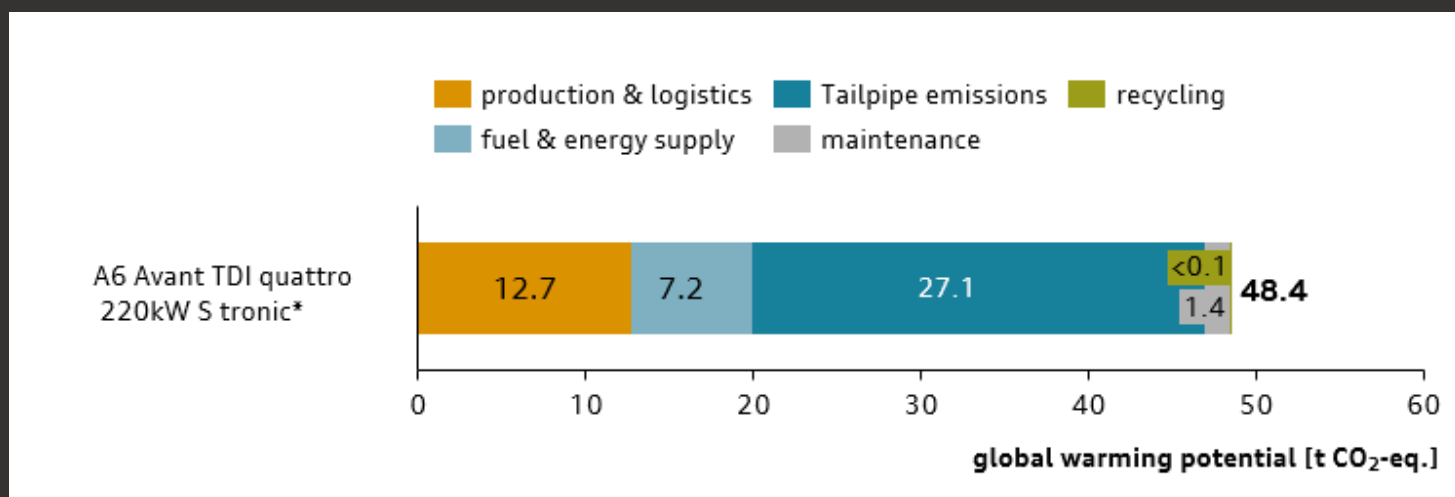


Figure 2: Global warming potential of the Audi A6 Avant TDI quattro 220kW S tronic* over the entire life cycle

The Results - Additional Impact Categories

In addition to the greenhouse potential, further impact categories were considered. The results for the entire life cycle are listed in the table below:

	Audi A6 Avant TDI quattro 220 kW S tronic*
Greenhouse potential GWP [t CO₂-eq.]	48.4
Ozone formation potential POCP [kg NO_x-eq.]	71.1
Acidification potential AP [kg SO₂-eq.]	90.0
Eutrophication potential EP [kg PO₄-eq.]	13.2

The photochemical ozone creation potential (POCP) describes the formation of photochemical oxidants, which can develop from hydrocarbons, carbon monoxide (CO), and nitrogen oxides (NO_x) under the influence of sunlight. These can impair human health, disrupt the function of ecosystems, and damage plants.

The acidification potential (AP) describes the effects of the emission of oxygen-forming substances such as SO₂ or NO_x. These substances have various impacts on soils, waters, ecosystems, biological organisms, and materials (e.g. buildings).

The eutrophication potential (EP) describes an excessive release of nutrients into waters and soils, leading to an undesirable shift in species composition. Additionally, eutrophication in waters leads to oxygen deficiency.

Conclusion

AUDI AG is aware of its responsibility towards the environment by putting vehicles on the market and is committed to the Paris Agreement on climate change. As part of this, AUDI AG is pursuing a consistent decarbonization strategy. The data basis for this is formed, among other things, by the life cycle assessments of the various vehicle models from Audi AG.

The life cycle assessment of the Audi A6 Avant TDI quattro 220kW S tronic* was checked by the external expert TÜV NORD CERT GmbH. Evidence of the rule-compliant application of DIN EN ISO 14040 was provided and a declaration of validity was issued.
