By submitting a request, you warrant that:

- You have a legitimate interest in accessing and processing RDDS data that is not overridden by the interests, fundamental rights, and privacy of any individual to whom this information relates;
- You will not use this service or any information provided by us in a way that is inconsistent with any applicable law, rule, regulation or statute or any policy issued by us;
- You will take reasonable precautions to protect any information provided by us from loss, misuse, alteration, or unauthorized access or disclosure;
